Rules and Regulations

Latest FIDE rules and Swiss system will be followed.

Time Control : 90 minutes each with seconds increment per move from move number one. Players are requested to bring their own International Chess sets (and chess clock if, any)

AICF & TNSCA Registration is Compulsory: AICF registration fee Rs.250/- for the year 2010 - 11. The registration fee will be accepted at the venue for the convenience of the participants.

TNSCA Registration : (Payable only by TamilNadu players) Rs.70/- for the year 2010 - 11. Those who have not registered with TNSCA for the year 2010 - 11 should send Rs.70/- towards TNSCA registration fee along with duly filled and signed TNSCA player's registration form with Date of Birth Certificate copy plus one passport size photo.

Tie-Break : Buchholz tie-break system will be adopted. In case of tie, prizes will not be shared.

Withdrawal : A player may be withdraw at any stage of the event, after informing the Chief Arbitrator in writing.

Protest : Protest, if any, against the decision of the arbiter shall be made in writing with a protest fee of Rs.500/- within 15 minutes of the incident. The protest fee will be refunded if the appeal is upheld.

Appeals Committee : A five member Appeals Committee will be formed at the players meeting. The decision of the appeals committee on all protest shall be final and binding.

Rights of Admission : The organizer KPK Chess Academy / Tiruppur DCA / TNSCA reserve the right to admit / refuse any entry without assigning any reason thereof.

- The organizer KPK Chess Academy / Tiruppur DCA/ TNSCA reserve the rights of admission to the venue and lodging places.
- Date of Birth Certificate is must for claiming category prizes. A player is eligible for only one prize.
- All players will be awarded with participation certificates.
- Strict silence must be adhered in the Tournament Premises.

Accommodation

Dormitory type of accommodation will be provided to the outstation players. Players should bring their own beddings. Many lodges with different tariff are available in the surrounding area.
